Congress leader Pramod Krishnan gets angry with Nath for organising Ram Katha by Bageshwar Dham

Dhirendra Shastri of Bageshwar Dham has said in Chhindwara that Gyanvapi is not a mosque but a temple. Shastri made the statement during Ram Katha being held under hospitality of MPCC president Kamal Nath. Everyone living in India is a follower of "Sanatan Dharma," Shastri said.



About Kamal Nath, Shastri said whosoever worships Lord Ram is his friend. On the other hand, a Congress leader got angry with Nath for getting Ram Katha organised by Dharendra Shastri.

Congress leader Pramod Krishnan tweeted: It does not behoove to senior Congress leaders to do the "aarati" of a BJP campaigner. A video clip of Nath doing the "aarati" of Shastri went viral. Krishnan

tweeted: It does behoove to a Congress leader to do the "aarati" of a person who has disgraced the Constitution by supporting demolition of houses and RSS's Hindu Rashtra agenda.

He further tweeted: The soul of Mahatma Gandhi, Pandit Nehru and Bhagat Singh must be writhing in pain, but the torch-bearers of secularism Mallikarjun Kharge, Digvijaya Singh and Jairam Ramesh are keeping mum.

According to BJP's state president VD Sharma, this is the real character of the Congress, and the Congress leaders should give a reply to Nath. Both Nath and Singh are Hindus only for election, Sharma said.

Singhar's demand for tribal CM heats up politics in state

Former minister Umang Singhar's demand for a tribal chief minister in the state has put his own party in trouble before the election. Such a demand of Singhar at Badnawar in Dhar district has generated a lot of political heat.

Singhar has put the BJP as well as the Congress in trouble. He advised tribal people not to keep quiet unless a tribal chief minister takes over the reins of power in the state. Singhar said, "I have told Kantilal Bhuria, that they have appointed you chairman of the election campaign committee, but they should make you the chief minister."

It does not matter whether the BJP or the Congress forms the government, but the tribal people should demand for a chief

minister from their community, Singhar said. BJP's state unit president said Singhar is unhappy. He further said the BJP gave a President from the tribal community.

On the other hand, the Congress treats the tribal people only as vote bank, Sharma said, adding that Singhar shows mirror to Kamal Nath and Digvijaya Singh from time to time. Home Minister Narottam

Mishra said he appreciated Singhar's boldness.

On the contrary, former minister Sajjan Singh Verma has targeted Umang saying since there is freedom of speech in the Congress, some leaders are taking advantage of it and issuing such statements.

Before making such statements, Singh should visit those areas where tribal people are living, Verma said, adding that Singhar should go to tribal areas to strengthen the party.

On Dharendra Shastri's statement of Hindu Rashtra, MP Congress president Kamal Nath said the country where 82% of people are Hindus what kind of Rashtra it will be. RUSSIA-UKRAINE WAR, CLIMATE CHANGE

25% dip in winged guests at Gandhi Sagar Sanctuary

The ongoing Russia-Ukraine war and climate change has led to decline in number of migratory birds visiting Gandhi Sagar Wildlife Sanctuary in Mandasaur district. This has been revealed in the 5th Bird Survey 2023

There are 29% migratory birds and 66% resident breeders. Shedding light on Russia-Ukraine war affecting migration of birds, survey report says that there is 17% decrease in waders (live near water and feed on fish) compared to their numbers in 2022.

This indicates that migration is disturbed as majority of waders missing this time were migratory birds. The global warming and seasonal changes have delayed migration. This is the reason that more species were seen in March 2022 compared to February 2023.

In the fourth Bird Survey, 246 species were sighted. Overall there is a dip of 8% in total species count compared to last year.

There is good news. In the 5th year count, 13 new species were identified, taking the tally to 298 species in the sanctuary spread across 368 square kilometres.

The report says Indian Vulture, Red Headed Vulture and White Rumped Vulture are in critical category. Egyptian Vulture and Great Knot are endangered species.

Six vulnerable species include Dalmatian Pelican, Greater Spotted Eagle, Indian Spotted Eagle, Saras Crane, Savanna Night Jar. There are 15 species, which are under nearly threatened category.



conducted by Wild Warriors Society, Indore. Migratory birds used to arrive from Mangolia, Russia, Sierra Leone. According to report, majority of birds at Gandhi Sagar Wildlife Sanctuary has resident birds and winter migrants (MGs), which constitute 95% of overall bird species. The number of winter migratory birds has decreased by 25% in 2023 compared to 2022. There is 3% dip in number of resident birds this year compared to 2022, which may be due to climate change. Of the 227 bird species sighted in Gandhi Sagar, 65 are winter migrants and 150 are resident breeders.
