LONDON: Fines imposed on employers and landlords who allow illegal migrants to work or rent from them are to be tripled from next year, the UK announced on Monday. The UK Home Office said from start of 2024, the penalty for employers will be raised to GBP

45,000 per illegal worker for a first breach from the previous GBP 15,000, and to GBP 60,000 for repeat breaches from GBP 20,000. Employers and landlords are expected to check eligibility of anyone they employ or let a property to in the UK.



Actor Raghavendra's wife dies in Bangkok

Prominent Kannada film actor-director Vijav Raghavendra's wife *Spandana* died in Bangkok on Monday, the family said.

Spandana (44) had gone on a trip to Thailand's capital with her cousins, and Raghavendra too had joined them after completing his shooting schedules.

"Last night, she went to sleep and did not get up in the morning. We believe it (death) is due to (complications arising from) low blood pressure," Sri Murali told reporters here, quoting his brother Raghavendra who called him up from Bangkok.

Spandana is the daughter of retired police officer BK Shivaram and niece of Congress MLC BK Hariprasad. She had acted in a movie



'Apoorva', making a guest appearance. Hariprasad said: 'Spandana did not get up in the morning. They are saying it's a heart attack".

Chief Minister Siddaramaiah and Deputy Chief Minister DK Shivakumar and several others expressed shock over her death and offered

George Floyd killing: Ex-cop handed state sentence

AP / Minneapolis (US)

Tou Thao, the last former Minneapolis police officer convicted in state court for his role in the killing of George Floyd, was sentenced Monday to 4 years and 9 months. Thao had testified that he merely served as a "human traffic cone" when he held back concerned bystanders who gathered as former Officer Derek Chauvin, who is white, knelt on Floyd's neck for 9 1/2 minutes while the Black man pleaded for his life on May 25, 2020. A bystander video captured Floyd's fading cries of "I can't breathe'

Floyd's killing touched off protests and forced a national reckoning of police brutality and racism. Hennepin County Judge Peter Cahill found Thao guilty of

aiding and abetting seconddegree manslaughter.

In his ruling, Cahill said Thao's actions separated Chauvin and two other former officers from the crowd, including an emergency medical technician. allowing his colleagues to continue restraining Floyd and preventing bystanders from providing medical aid. "There is proof beyond a reasonable doubt that Thao's actions were objectively unreasonable from the perspective of a reasonable police officer, when viewed under the totality of the circumstances. Thao's actions were even more unreasonable in light of the fact that he was under a duty to intervene to stop the other officers' excessive use of force and was trained to render medical aid," Cahill


Multinational force fights stubborn wildfire in Cyprus

AP / Nicosia (Cyprus)

A multinational force is helping Cyprus fight stubborn wildfires in the summer heat, with Lebanon joining Greece and Jordan in sending aircraft to fight a blaze that has scorched miles of mountainous terrain, officials said on Monday. Cyprus Foreign spokesman Ministry Theodoros Gotsis told The Associated Press that neighto send a pair of choppers as the wildfire continues to reignite on several fronts. Two Greek Canadair aircraft have been dispatched to help douse the fire in the mountains about 11 miles (17 kilometres) north of the coastal town of Limassol.

Jordan has sent three aircraft of its own, including two Super Puma helicopters and a Russian-made Mi26

helicopter. The multinational effort is battling a blaze that ac-
