

- I. The Name of the Company is **WORTH PERIPHERALS LIMITED**.
- II. The Registered Office of the company will be situated in the state of **Madhya Pradesh**.
- III. The Objects for which the company is established are:


(A) THE OBJECTS TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE:-

1. To carry on the business of manufacturers, producers, assemblers printers, importers, exporters, stockists, dealers and agents in corrugated paper rolls, boxes, cartons, containers, fourfold boxes, laminated boxes, corrugated paper sheets, packaging products in paper, plastics, polymers, ferrous and non ferrous metals, glass or wood or combinations thereof.
2. To carry on the business of marketers traders, repairs assemblers and manufacturers of machineries for various packaging products and to deal in various raw materials used in above packaging products.

**(B) OBJECTS INCIDENTAL OR ANCILLARY TO THE ATTAINMENT OF THE MAIN OBJECTS
ARE:**

1. To acquire and take over any going concern's business dealing in the products or the company & their intermediates and such other products at any place or places as carried on by them as a partnership firm, proprietary concern and company with all or any of the assets and liabilities of the said concern including imports and other quota, rights, licenses, permits, telephone and all other properties movable, immovable and all trades connected thereto, to adopt, become parties to and to enter into such agreements or other deeds, instruments and writing may be deemed proper or advisable and to agree to make such modification therein as may be thought fit and to carry the same into effect with or without modification and to give, or acquire know-how, technical information specification data, methods of analysis to or from any Indian/foreign, person/s Firm/s company/companies in any part of the world and to establish business, branches, offices, research centers, import/export houses and/or to acquire purchase, hire, manage, control superintend either solely or jointly or in collaboration with any Indian and/or Foreign person/s firm/s Industry/ies

Company/Companies business shop, factory in any part of the world for the purpose of carrying out the objects of the company.

2. To take all necessary or proper steps in any legislature (Central or state) or with the authorities. Government, local or municipal bodies or otherwise of any place in which the company may have Interest and to carry on any negotiations or operations for the purpose of directly carrying out the object of the company or effecting any modifications in the construction of the company or further in interests of its members and to oppose any steps taken by any person, company which may be considered directly or indirectly to prejudice or likely, to be prejudicial to the interests of the company or its members. But the company shall not act as a trade union.
3. To depute or receive Directors, representatives or employees of the company to or from any part of India or abroad for the purpose of promoting, conducting more profitably all or any of the businesses of the company and for entering into arrangement/agreement with any person/firm, company in India or in any foreign country in that behalf and also for purchasing or otherwise acquiring the exclusive or limited rights of exportation, subject to law of the land, to obtain from any Government or authority or any one where-so ever any orders or licenses concessions, privileges orders of the Board of Trade and rights or other form of statutory or official authority that may seem to the company as conducive to the carrying into effect any objects of the company and to exercise, utilise and comply with the same.
4. To purchase, take on lease, exchange or otherwise acquire and hold any lands, interest in any movable properties of any kinds necessary or convenient for the company's business, whether in India or in any part of the world and to erect, lay down, maintain, reconstruct and adopt any buildings, offices, work-shops, mill, plants, machinery, merchandise, goods, articles.
5. To apply for purchase or otherwise acquire and protect and renew in any part of the world any patent, patent rights, divides, diventions, trademarks, designs, licences, concession and like, conferring any exclusive or non-exclusive or limited right to their use of any secret or other information to any invention which may seem capable of being used for any of the purposes of the company or the acquisition of which may seem calculated directly or indirectly to benefit the company and use, exercise, develop or grant license in respect of or otherwise turn to account the property, rights or information so acquired and to account the expended money upon testing or improving any such patents, inventions and rights.
6. To establish, provide maintain and conduct or otherwise subsidize research laboratories & experimental workshops for scientific and technical research and to undertake and carry on with all scientific and technical researches experiments and tests of all kinds and to promote studies and Research both for scientific and technical investigation and invention by providing, subsidising, Endeavoring or assisting laboratories, workshop, libraries, lectures meetings and conferences and generally to encourage promote and reward studies, researches, investigation, experiment, tests and inventions of all kind that may be considered likely to assist any of the businesses which the company is authorised to carry on.
7. To explore, examine, investigate, test and make experiments, obtain reports, opinion of expert certificates of analysis, survey, plans of information, in relation to any property or rights which the company may acquire or become interested in or with a view of discovering preparation or rights which the company may acquire or become interested in and to engage, employ, pay fees, to retain services of and to send any pact to the world agents, explorers, engineers, lawyers, counsels

or others and to find out and dispatch expedition for the purpose of exploring or ascertaining boundaries or making investigation of any nature what-so-ever.

8. To enter into partnership or into any arrangement for sharing profits, union of interest, co-operation, Joint adventures, reciprocal concessions or otherwise with any person or company carrying on or engaged in or about to carry on or engage in any business or transaction which the company is authorised to carry on or engage in or any business or transaction capable of being conducted so as directly or indirectly to benefit the company and to lend money; to guarantee the contract or otherwise acquire shares and securities of any such company and to sell, hold, issue with or without guarantees or otherwise deal with the same. But the company shall not do the Banking Business as defined under - the Banking Regulation Act. 1949.
9. To exchange, convey, mortgage, assign or let on lease the whole or any part of the property (whether movable or immovable) of the company and to accept as consideration in lieu thereto other land or cash or government security guaranteed by Central or State Government or shares, debentures, stocks, bonds or securities of any other joint stock company or companies or partly the other or such other properties or securities as may be determined by the company and to take back or re-acquire any property so disposed off by repurchasing or leasing the same for such prices and on such terms and conditions as the company may think fit.
10. Subject to the provisions of Section 58-A & 293 of the Companies Act, 1956 and the rules made there under and directives of Reserve Bank of India, to receive money on deposit or loan from Bank, Financial Institutions or Public upon such terms as the company may approve and to guarantee the debts and contracts of customers and others provided that the company shall not carry on the business of Banking as defined under the Banking Regulation Act 1949.
11. To pay out of the funds of the company all expenses of an incidental to the formation, registration or advertisement and establishments of the company, printing, stamping, circulating of proxies and forms to be filled up by the members of the Company.
12. Subject to provisions of the Companies Act, 1956 to distribute as bonus shares amongst the members or to reserve or otherwise to apply as the Company may from time to time determine any money received in payment of dividends accrued on forfeited shares and moneys realized from the sale by the Company of the forfeited shares or any moneys received by way of premium on shares or debentures issued as a premium by the Company.
13. To invest the money of the company not immediately required upon such stocks, shares and securities and in a manner as may from time to time be determined and subject to the provisions of any law for the time being in force.
14. Subject to provisions of the Companies Act 1956, to distribute among the members in specie any Property of the company or any proceeds of sale or disposal of any property of the company in the event of winding up.
15. To provide for the welfare of Directors of the company or its predecessors in business and the wives, widows and families or the dependents or connection of such person by building or contributing to the building of houses or dwelling or quarters by grant of money, persons, gratuities, allowances, bonuses, profits sharing from time to time subscribing or contributing to provident fund and other associations, institutions, funds, profits sharing or other schemes or trusts and by providing or subscribing or contributing towards places of instructions and

recreations hospitals and dispensaries medical and other attendance and other assistance the company shall think fit.

16. To advertise & adopt such means of making known the business of the company or any products or goods trade or dealt in by the company in any way that may be thought advisable or expedient and in particular by advertising in the press by circulars, by purchases and exhibition of works of arts or interest, by publication of work, periodicals and by granting prizes, rewards and donations.
17. To remunerate any corporation or person whether a Director of the Company or not, in the form of brokerage, commission, royalty for technical know-how and for others or otherwise for an services rendered to the company.
18. To provide for the welfare of a person employed or formerly employed by the company and the Wives, families, dependants by building or contributing to the buildings or houses, dwellings or chawls or by grants of money, bonus, allowances or other payments or by creating and from time to time subscribing or contributing to provident fund and other associations funds or trusts or by helping persons employed by the company, to effect or maintain insurance on the lives by contributing to the payment or otherwise and by providing or subscribing or contributing towards places of instructions and recreations, hospitals and dispensaries, medical and other attendants and other assistance as the company may think fit.
19. To subscribe or otherwise to assist or to guarantee money to charitable, benevolent, religious scientific, national, public or other institutions or objects which shall have any moral or other claims to support or aid by the company either by reasons of locality or operations of public and general utility.
20. To open account or accounts with any bank or banks or and to pay into and withdraw money from such account or accounts.
21. To sell or dispose off the undertaking of the company or any part thereof for such consideration as the company may think fit and in particular for shares, debentures or securities of any other company having objects altogether or part similar to those of this company.
22. To amalgamate or merge or absorb with/by any other company/companies.

(C) OTHER OBJECTS:

1. To carry on all or any of the business of prospecting, exploring, opening and working mines, drill and sink shafts or wells and to pump, refine, raise dig and quarry for, oil, petroleum, gold, silver, diamonds, precious, stones, coal, earth, limestone, iron, aluminum, titanium, vanadium, mica, apalite, chrome, copper, gypsum lead manganese, molybdenum, nickel, platinum, uranium, sulphur, tin, zinc, zircon, bauxite and tungsten and other ores and minerals.
2. To carry on the business of manufacture of, dealers in, importers/exporters of Chemicals and pharmaceutical goods of all kinds, including acids, salts, alkalies, antibiotics and other pharmaceutical, medicinal and chemical preparations articles, compounds, dyes, cosmetics, paints, pigments, oils, varnishes, resins, synthetics, soaps and other cleaning agents of all kinds and descriptions including its compounds, raw materials and ingredients.

3. To carry on all or any of the business of manufacturers, exporters/ importers, and dealers in organic and inorganic chemicals, petrochemicals, chlorine, fertilizers, manures, pesticides, soda ash, caustic soda, calcium carbide, ethyl, alcohol, coal tar, hymedicines, ointments, essences, acids.
4. To carry on all or any of the business of engineers, founders, smelters, fabricators, smits, metal workers, metallurgists, electric and chromium platers, polishers, painters, tinsmiths, lock-smiths, iron managers, alloy makers, and machinists and manufacturers of and dealers in machinery, tools, instruments and equipments of all kinds used in mining, refining, manufacturing and processing of ores, mineral goods and materials.
5. To carry on the business of manufacturers and fabricators of and dealers in machinery, machine, tools, implements, engineering products, machinery spares and components, of all types and in particular to manufacture produce repair, alter, convert, recondition, prepare for sale, buy, sell, hire, import, export, let out on hire trade and deal in machine tools and implements, other machinery, plant, equipment, article, apparatus, appliances, component, part, accessories, fittings and things in any stage or degree of manufacture, process or refinement.
6. To carry on all or any of the business of manufacturers, of importers, exporters and dealers in hirers, repairers and warehouses of aeroplanes, helicopters, cars, lorries buses, vans, cycles, tractors, motor cycle, scooters, wagons, locomotives, earth moving equipments, ships, boats, barges, travelers, submarines and aircraft vehicles and vessels of every description and their components and accessories.
7. To carry on all or any of the business of manufacturers of importers, exporters and dealers in forgings, castings, and stampings of all metals, tools, bolts, nuts, nails, rivets, hinges, hooks, handles, buckets, bath tubs, tanks, trunks, metal furniture, sewing machines, safes, chimneys, pipes dies, jigs, measuring tapes, automobile parts, agricultural implements, armaments, tanks, guns, and parts and components of all kinds of machinery.
8. To carry on all or any of the business of manufacturing, processing and dealing in iron and steel, Ferro alloys, special steels, aluminum copper lead, zinc, and their alloys, and products and of manufacturing and dealing in industrial machinery boilers, internal combustion engines, ball, roller, and tapered bearing, tubes, cables, wires, pipes, cookers, printing machinery and textile machinery and their components and accessories.
9. To carry on the business in India or elsewhere of manufacturers, dealers, merchants, traders, exporters, importers, stockists, distributors in all kinds of spinners, weavers, cloth, manufacture readymade garments, leather cloth, knit wears, handicrafts, coir products, furriers, hosiers, tailors, hatters, outfitters, glovers, shoes, bags, carpet, umbrellas, brushes, comps, razors, blades and scissors.
10. To carry on all or any of the business of manufacturers of importers, exporters and dealers in glass, glass-products including sheets and plate glass, optical glass, glass wool, laboratory ware, bottles, jars, containers, thermo bottles, enamelware, and receptacles, of all kinds and wood products, including plywood, matches, furniture, boxes, windows, doors, tools and other articles and products in which timber or wood is used and to act as timber and lumber merchants and the proprietors of saw mills.
11. To carry on all or any of the business of manufacturers, of importers, exporters and dealers in hirers and repairs of electrical machinery, equipments and appliances of all kinds and descriptions including motors, batteries, dynamos, bulbs, armatures, magnets, conductors, insulator

transformers, convertors, switch board, PVC cables & wires, air conditioners, refrigerators, domestic appliances and electronic equipments, including radars, business machines, radios, television sets, tape recorders, gramophones, records, tapes and tele-communication equipment and telephone equipment and their components and accessories, including transistors, resistors condensers and coils.

12. To carry on all or any of the business of manufacturers of exporters, importers and dealers an workers in cement, lime, plasters, ceramic, sanitary fittings, asbestos sheets, chinaware, whiting clay, gravel, sand, minerals earth, coke, fuel and stone and builders requisites and conveniences of all kinds.
13. To carry on all or any of the business of makers of and dealers, importers, exporters in scientific and industrial instruments of all kinds, for indicating recording, controlling, measuring and timing and machine tools, precision tools, surgical instruments, and appliances and artificial limbs, dental and optical equipment and goods, anatomical, orthopedic and surgical appliances of all kinds and providers of all requisite for hospitals, patients and invalids.
14. To carry on all or any of the business of manufacturers of and dealers in importers, exporters of pulp and paper of all kinds and articles made from paper or pulp and materials used in the manufacture or treatments of paper, including packaging goods and materials such as bags, cartons, containers, and boxes whether made of paper, plastic or any other materials and pens, pencils and ball pens.
15. To carry on all or any of the business of goldsmiths, silversmiths, jewelers, gem and diamond merchants and of manufacturing and dealing in clocks, watches, jewellery and their components and accessories and or producing acquiring in metals, ferrous or non ferrous bullion, gold, ornaments, silver utensils, diamonds precious stones, paintings, coins manuscripts, curious antiques and objects of art.
16. To carry on all or any of the business of generating and distributing electricity, gas and heat and of manufacturing of dealing in all kinds of machinery, equipment and appliances required for generating, distributing, employing, and consuming electricity and of acting as electrical engineers and contractors and of purifying and distributing water.
17. To carry on all or any of the business of constructing buildings, roads, bridges, dam, ports and working as builders and contractors, architects, decorators and manufacturers and processors of and dealers in all kinds of building materials including bricks, tiles, marbles granites, hardware, cement, sanitary goods, road making materials and of acting as estate agents, brokers managers of estates and properties and of acquiring premises on lease and giving them on sublease.
18. To carry on all or any of the business of cultivating, producing and dealing in agricultural products including food grains, cash crops, fruits, wines, vegetables, flowers tea, coffee, cinchona, cotton, rubber, and the business of dairy farming, including making of condensed and powdered milk, cream, cheese, butter, and other milk products and the business of poultry farming, live stock breeding and processing and canning of food articles, spices, fruits and vegetables and of cultivating and exploiting forests and utilizing forest products.
19. To carry on all or any of the business of millers bakers butchers, confectioners and makers and Manufacturers of and dealers in flour, rava, maida, biscuits, bread, sugar, gur, khandsari, molasses, syrups food articles of all types and description.

20. To carry on all or any of the business of carriers of passengers and goods and merchandise by air, sea or surface transport and to maintain airways, shipping line, road ways and other transport services and to act as clearing agents, forwarding agents, travel agents, charterers, tour agents and freight contractors.
21. To carry on the business as buyers, sellers, importers, exporters, agents, commission agents, forwarding agents, clearing agents, distributors, warehouse men, merchants, traders, sales organizers representatives, of manufacturers of all kinds of commodities, goods, article materials and things and for that purpose to buy, to sell, exchange market, pledge, distribute, install, service maintain or otherwise deal in all kinds of commodities, goods articles and things.
22. To carry on all or any of the business of salt making, fishing producing distributing and exhibiting films, of manufacturing and dealing in cameras and photographic equipments and materials and of renting of hiring out or dealing in all kinds of machinery, equipment, furniture, vehicles, ships, automobiles, aeroplanes, fans sewing machines and other things.
23. To carry on all or any of the businesses or running hotels, restaurants, lodging houses, milk and snack bars, laundries libraries, swimming pools, night clubs, hair dressing and beauty saloons, chemist shops, cold storages cinemas, theatres, studios, exhibition halls, amusement centers, wine and beer shops, department stores hospitals clinics, nursing homes, maternity and family planning units pathological laboratories, optician shops, massage houses, concert and dancing halls, discotheques, schools, colleges and training institutions circuses, sports clubs, skating halls, boating and padding pools, radio and television stations, garage and service stations, repair shops, petrol pumps, gymnasiums safe deposit vaults, warehouses, godowns, car parks, hangers and race course.
24. To carry on all or any of the business of procuring, developing and supplying technical know how, patents, inventions, drawing designs and other scientific formulas, and processes for the manufacture of processing of goods and materials and for the installation or erection of machinery or plant for such manufacturing and processing and for the working of mines, oil wells, and other sources of minerals and deposits and for search and discovery and testing mineral deposits and for carrying out any operations relating to agriculture, husbandry dairy or poultry farming, forestry and fishing and of rendering services in connection with the provisions of such technical know how.
25. To carry on all or any of the business of guaranteeing the performance of any contractor or obligation of any company, firm or persons and of guaranteeing the payment and repayment of the capital and principal of dividend, interest or premium payable on any stock, share and securities debentures, debenture stock, mortgage loan and other securities issued by any company, corporation, firm or persons, including (without prejudice to the said generally) bank overdrafts, bills of exchange and promissory notes and generality of giving guarantees and indemnities and guaranteeing the fidelity of persons filling situations of trust or confidence due performance of duties.
26. To carry on all or any of the business of undertaking or arranging for the writing and publication of books, magazines journals or pamphlets on subjects relating to trade, commerce, industry, agriculture, medicine, banking insurance, investment, taxation, finance economics, law and other subjects.
27. To carry on the business of dealers and/or investors in metals, bullion, gold, silver, diamonds, precious stones, ornaments, and jewellery and paintings and coins and manuscripts and objects of




